Minutes Of The Meeting For Evaluation Of Technical Bids For "Feasibility Study For Re-Operationalization Of Agriculture Light Engineering Program (Mardan), Leather Goods Services Center & Automotive Center (Bannu), And Mobile Training Unit (Peshawar)

Subject meeting was held under the Chairmanship of Managing Director, SIDB in his office at 1100 hours on 12-03-2024 to finalize the Technical bids evaluation of the "Feasibility Study for Re-Operationalization of Agriculture Light Engineering Program (Mardan), Leather Goods Services Center & Automotive Center (Bannu), and Mobile Training Unit (Peshawar)", Attendance Sheet of the officers attended the meeting is Annexed at F-I);

- Dy. Managing Director, P&M informed the forum that in pursuance to the SIDB Board of Directors 104th meeting decision a committee was notified on 11-04-2022 for completion of the procurement process and evaluation of reports submitted by the consultant for re-operationalization of the closed centers of SIDB, namely Agriculture Light Engineering Program (Mardan), Leather Goods Services Center & Automotive Center (Bannu), and Mobile Training Unit (Peshawar). In this connection, the advertisement was published in national dailies as INF(P) 3488/2022 on 13th June, 2022. In response three (03) bids were received, all the applied firms failed to secure minimum qualifying marks of seventy (70) in their technical proposals. Consequently, as per the evaluation committee decision the subject study was re-advertised vide INF (P)2642/23 on 28-10-2023, whereof two (02) bids from following consultancy firms were received, technical bids of which were opened on 15-11-2023.
 - 1. M/S IGES International Engineering Consultant.
 - 2. M/S Engineering and Technical Associates JV NJHR Chartered Accountants.
- The technical bids of the aforesaid firms were thoroughly examined by the evaluation committee members in light of the evaluation criteria as per RFP documents under the Chairmanship of MD, SIDB. During technical bids evaluation of the aforesaid firms, M/S Engineering and Technical Associates JV NJHR Chartered Accountants was found technical responsive as it secured qualifying marks of seventy eight (78.52) in their technical proposals. While M/S IGES International Engineering Consultant failed to secure qualifying marks i.e. seventy (70), and scored sixty four (64) marks. Comparative statement of technical bids was prepared and is annexed at F-II.

- 4. The committee decided to recommend technical evaluation of the firm to MD SIDB for approval and it's uploading on KPPRA and SIDB website. The committee further decided to recommend opening of financial bid of the firm at 11:AM on 22 March, 2024.
